#### PREPARING FOR THE FALL 2019 SEMESTER...

The teams from Hokie Passport Services and the Bursar's Office have been exceptionally busy as students prepare for the start of the Fall 2019 semester.

Over the course of Transfer and First-Year Orientation (July 8– August 2), Hokie Passport Services produced a total of **8,745** student IDs. The team anticipates making another 567 as part of International and Make-Up Orientation, bringing the overall total to more than 9,300 cards produced.

An estimated total of **10,922** family members and guests will have been served by the conclusion of all orientation activities.

#### UPDATE TAX FORMS ONLINE

New and current Virginia Tech employees who are also U.S. citizens or permanent residents can now complete or update their federal W4 and Virginia VA4 tax forms online in Hokie Spa.
